The undersigned is directed to inform that some of the private AI technicians and progressive farmers are undertaking artificial insemination with imported semen and are not registered on INAPH data base. Information of animals covered by these technicians/ progressive farmers about vaccination and artificial insemination is not being uploaded on INAPH data base. At present traceability of these animals is not being maintained as per the guidelines of the scheme National Animal Disease Control Programme. Hence it is essential that these animals are tagged using 12 digit AUID supplied under NADCP scheme and their data uploaded on INAPH data base.

2. It is requested that State Animal Husbandry Department may take up registration private AI technicians/ progressive farmers undertaking AI and vaccination on INAPH data base and send request with all details to NDDB for registration of private AI technicians/ progressive farmers on INAPH data base. State Animal Husbandry Departments are also requested to supply 12 digit polyurethane tags to progressive farmers/ private AI technicians undertaking AI and vaccination of animals.
