

Companies doing the milk business (Procurement and Processing of milk) having FSSAI certificate on the rates, incentive which are applicable as per the milk procurement pricing policy of DMS from time to time on the agreement basis from 01.04.2022 to 31.03.2023 or till handing over of operation and management of DMS to any external agency/ closing of DMS activities by Deptt. of AH&D, whichever is earlier. In addition to the above, they can also offer for supply of Concentrated Skimmed Milk (CSM).
