 - EMD:** The offer must accompany with EMD of Rs. 10,000/- in the form of DD/FDR/ Bank cheque in favour of General Manager, Delhi Milk Scheme failing which the offer will not be considered. Micro & Small Enterprises (MSME) are exempted from EMD. EMD shall be released after receipt the material in DMS.

Micro and Small Enterprises registered with District Industries centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by ministry of Micro, small and Medium Enterprises are exempted from depositing Tender Fees & EMD. GENERAL TERMS & CONDITIONS

1. The rates offered should be for Nitric Acid B.I.S Standard certified IS-264:2005 As per Technical Grade, HNO₃ Strength Minimum 52% by mass, to be supplied in 40-50 kgs plastic (Refundable) Black jar in 3-4 lots/as and when required. Quantity i.e. 20,000 kgs is to be supplied as and when required basis as intimated by telephonically. (Sample may be passed by QCL, DMS before supply)
2. The requirement may vary upto 30% more or less and supply will have to be made accordingly, on demand by General Manager, Delhi Milk Scheme or any officer acting on behalf of him. General Manager, Delhi Milk Scheme reserves the right to extend the contract by 90 days.
3. Rates offer must be firm and final. Rates offered of the goods for delivering the same in DMS premises inclusive of Excise Duty, Sales Tax, Packing Forwarding, Transportation and Octroi etc.
4. The offer must accompany with EMD of Rs. 10,000/- in the form of DD/FDR in favour of General Manager, Delhi Milk Scheme failing which the offer will not be considered. Micro & Small Enterprises (MSME) are exempted from EMD.
5. You will be required to submit a Security Deposit equal to 10% of the value of the order. The security deposit will be released only after completion of the order. No claim shall be against the Govt. for interest thereon during the period security deposit remains in the custody of the Govt.
6. Suppliers must be prepared to commence the supplies within 15 days from the date of issue of the supply Order. However, they are permitted to indicate the earliest date for commencement of the delivery of the material.

General Manager, Delhi Milk Scheme reserve the right to cancel the Supply order without any separate notice on expiry of the delivery period in the event of non supply of goods within the delivery period and or the quality of goods supplied having been found not as per specifications leading to rejection on inspection of the goods supplied by stipulating the option on the time of issual of the final acceptance of order and Government is no way to responsible to compensate the supplier(s) on account of such cancellation of the supply order.
8. Payment will be released to you after supply of material as per schedule and submission of pre-receipted bill in triplicate to ASO(R&G) duly revenue stamped.
9. Inspection shall be carried out by the authorized representative of General Manager, Delhi Milk Scheme in DMS premises. In case of rejection, you shall be required to take back the rejected stores & replace the same on free of cost basis within the overall stipulated delivery period.
10. General Manager, Delhi Milk Scheme reserves the right to Cancel/short close the order without assigning any reason thereof.
11. **JURISDICTION:** All disputes arising out of or raised on this contract, shall be subject to the Jurisdiction of Court of Union Territory of Delhi.
