3. **Manual offer** shall not be accepted.

4. **Offer Validity:** your offer should be valid for a period of 90 days.

6. **Payment Terms:** Payment shall be made through RTGS/PFMS after receipt, inspection and acceptance of material. The supplier is required to send Bank Detail alongwith Bill for making payment.

7. Bidders/offers not accepting the terms and condition of this e-tender enquiry are liable to be rejected.

8. **Price Variation Clause:** If any party desires price variation clause, the same may be clearly mentioned in the offer giving price breakup of offered rate as on date of applying offer/bid. Request for the price variation shall not be accepted at later stage.


**Exemption from EMD/Tender Fee:** (a). Micro and Small Enterprises registered (for relevant category of purchase of material/service) with District Industries centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by ministry of Micro, small and Medium Enterprises are exempted from depositing Tender Fees & EMD. These Firms shall be given due consideration as per Public Procurement Policy for Micro and Small Enterprises (MSME) order 2012. **GENERAL TERMS & CONDITIONS**

1. Oxygen Gas/DA Gas is to be supplied in suppliers returnable cylinder fitted with protective cylinder cap to avoid any damage to the control valve and accidents. The supplier shall be responsible to deliver the cylinder filled with oxygen Gas /DA Gas in DMS West Patel Nagar, New Delhi and collection of empty cylinders from DMS for which no extra payment shall be made.
2. In case there is any increase in the price levied by the manufacturer or by the Govt. during the delivery period prescribed in the order, the supplier shall be compensated by granting escalation in price at the same unit rate on production of documentary proof thereof. Similarly the supplier shall pass on any benefit accruing out of any decrease in the price of oxygen gas /DA gas to DMS.
3. Minimum free period for which cylinders may be kept by, Delhi Milk Scheme without rent shall be 30 days. However, suppliers may clearly give the free re-retention period of the cylinder in their offer. Rental charges payable after the free delivery period should be clearly mentioned in the offer.
4. Party has to ensure that the cylinder delivered have cap fully fitted on them for safety purpose and also they shall have the desired pressure.
5. General Manager, Delhi Milk Scheme at his sole discretion may extend the contract for a period of 90 days from the date of its expiry by issuance of a letter in writing on any date within the currency of the contract. The quantity shown is approximate. The same can be increased or decreased upto 30%.
6. Payment will be released after receipt of material as per schedule and submission of pre-receipted bill in triplicate to ASO(R&G) duly revenue stamped.
7. General Manager, Delhi Milk Scheme reserves the right to Cancel/Short close the order without assigning any reason thereof.
8. Prices shall be FOR DMS.
9. All disputes are subject to Delhi jurisdiction.
10. Party has to give a certificate & the quantity of gas mentioned on each cylinder will not be less than what has been specified. This is to ensure the quantity quarter.
11. All disputes are subject to Delhi jurisdiction.
