- 2. On Line Rates/Offer:** Only online offer shall be accepted.
- 3. Manual offer** shall not be accepted.
- 4. Offer Validity:** your offer should be valid for a period of 90 days.
- 5. EMD:** The offer must accompany with **EMD of Rs.10,000/-** in the form of **DD/FDR/ Bank cheque in favour of General Manager, Delhi Milk Scheme** failing which the offer will not be considered. Micro & Small Enterprises (MSE), SSI, NSIC registered firm are exempted from EMD if they are registered for relevant category of purchase of material/service. EMD shall be released after receipt & acceptance of the material in DMS.
- 6.** The Successful Party will have to submit Security Deposit equal to 10% value of order after award of the contract, which shall be released after successful completion of the contract including performance of the contract.

10. Price Variation Clause: If any party desires price variation clause, the same may be clearly mentioned in the offer giving price breakup of offered rate as on date of applying offer/bid. Request for the price variation shall not be accepted at later stage.

Exemption from EMD/Tender Fee: (a). Micro and Small Enterprises registered (for relevant category of purchase of material/service) with District Industries centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by ministry of Micro, small and Medium Enterprises are exempted from depositing Tender Fees & EMD. These Firms shall be given due consideration as per Public Procurement Policy for Micro and Small Enterprises (MSE) order 2012. Proof of registration as Micro and Small Enterprises for relevant category may be enclosed.

(b). All manufacturers/suppliers/Dealers/Bidders are requested to register your firm immediately on GeM i.e. Government e marketplace (gem.gov.in) as it is mandatory to purchase all goods/materials and services.

13. As this is e-Tender Enquiry, bidder is required to obtain Digital Signature Certificate (DSC) for bidding the above Tender.

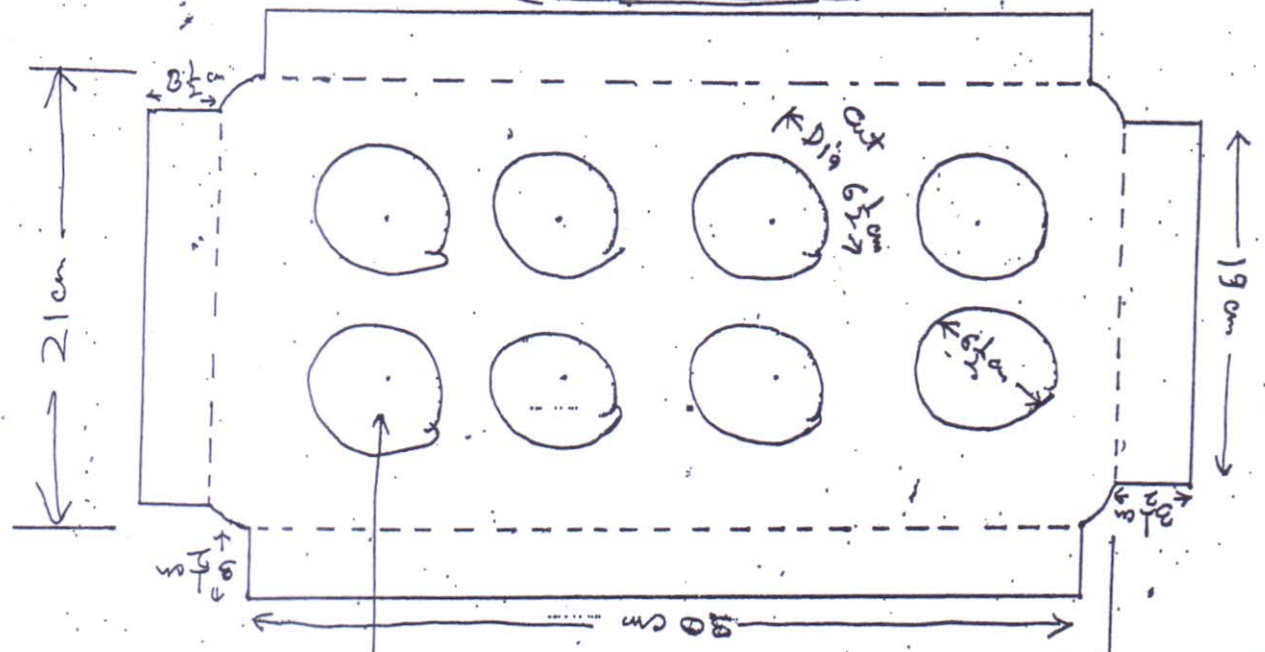

Specification for CardBoard 3-ply Dahi Cup Holder Gatta

1. This is for keeping and holding Dahi Plastic Cups for packing/distribution and to be kept in Plastic Green Milk Crates.
2. 3-Ply Cardbord Gatta (3 ply gatta have one fluted medium sandwiched between two sheets of plain Kraft Paper. made of Food Grade material.
3. Attached Design is Rough, Party has to visit Delhi Milk Scheme Premises, and Party will have to design it in consultation with Manager (Processing). Before making supply sample must be shown to Delhi Milk Scheme. *and getting test*
4. The Strength of Gatta should be such that it can hold and keep Dahi cups of 100gm and 200 gms safe from damage.
5. Strength should be such that it can hold Dahi 100 gms cups in double decker type if required.
6. Dahi-filled crates are to be kept in Heating room at 48 Degree Celcius and in Cold Store at 2-4 Degree Celcius Temp, so it should be not got damaged or loosen during cold-store holding.
7. Each Bundle should be supplied in 100 gattas bundle each.
