6. **Payment Terms:** Payment shall be made through RTGS/PFMS after receipt, inspection, and acceptance of material. The supplier is required to send Bank Detail alongwith Bill for making payment.

7. Bidders/offers not accepting the terms and condition of this e-tender enquiry are liable to be rejected.

8. **Price Variation Clause:** If any party desires price variation clause, the same may be clearly mentioned in the offer giving price breakup of offered rate as on date of applying offer/bid. Request for the price variation shall not be accepted at later stage.

Micro and Small Enterprises registered (for relevant category of purchase of material/service) with District Industries centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by ministry of Micro, small and Medium Enterprises are exempted from depositing Tender Fees & EMD. 11. As this is e-Tender Enquiry, bidder is required to obtain Digital Signature Certificate (DSC) for bidding the above Tender.


