ORDER

Whereas, the Hon'ble High Court of Delhi vide their order dated 20.10.2014 in WP No. 2780/11 filed by Dr. C.S. Sahukar & Others directed this department 'to ensure that DACP is granted to veterinary officers on the basis of the CPC's recommendations implementation to GDMOS and Dental doctors from the date the latter category (Dental Doctors) were given that benefit'

2. Whereas, this Department in consultation with the Deptt. of Expenditure and Deptt. of Legal Affairs filed a SLP in the Hon'ble Supreme Court of India challenging the direction given by the Hon'ble High Court of Delhi and the Hon'ble Supreme Court of India dismissed the SLP No. 3505 of 2015 filed by this Department.

3. Whereas, this Department consulted the Deptt. of Expenditure and Deptt. of Legal Affairs in view of the dismissal of SLP filed by this Department and the Deptt. of Expenditure advised this Department to implement the order dated 14.10.2014 of the Hon'ble High Court of Delhi in case of petitioners with the following observations :

'As regards the question of its extension to similarly placed persons, a suitable proposal bringing out the number of employees involved, the financial implication and also the financial implications based on withdrawing Modified Assured Career Progression (MACP) as both the MACP and DACP cannot be given together, may be worked out.'

4. Whereas, the directions of the Hon'ble High Court of Delhi vide their order dated 14.10.2014 has been considered by this Department in consultation with Deptt. of Expenditure and Deptt. of Legal Affairs as recorded above for extending the benefits of DACP scheme to the 24 veterinarians of the Department being the petitioners in the WP No. 2780/11 filed by Dr. C.S. Sahukar & Others from the date of the benefit given to the Dental Doctors by the Ministry of Health and Family Welfares vide their order No. A 45012/1/2002-CHS. VI dated 25.08.2006 and a 45012/2/2008-CHS.V dated 29.10.2008.

DACP scheme provides promotion to the Central Health Service Officers without linkage to vacancies upto the level of NFSG (Director level) w.e.f. 29.08.2006 and up to the level of SAG (JS level) w.e.f. 29.07.2008 as per order issued by the M/o Health and Family Welfare recorder above. The details are as under in case suitably modified for Veterinarians in DADF:

Now therefore, the approval of the competent authority is conveyed for implementing the DACP scheme in respect of the Veterinarians petitioners, pertaining to DADF, in the WP No. 2780/11 filed by Dr. C.S. Sahukar & Others as extended to the Dental Doctors by the Min. of H&FW as recorded above after following due procedures like Departmental Promotion Committee and fulfilment of other formalities as per DOP&Ts instructions in this Department. Other conditions for effecting promotions will be governed by the provisions of Recruitment Rules pertaining to the Veterinarians of DADF. On implementation of DACP scheme, the MACP already sanctioned to the veterinarians will stand withdrawn.

6. The amendments to the relevant recruitment rules whenever necessary consequent upon the above decision, shall be made in due course

7. This issues with the concurrence of Ministry of Finance (Deptt. of Expenditure) vide ID No. 8-21/2017-E.III (A) dated 20.02.2018, eFTS 716613/2018 and ID No. 8-21/2017-E.III(A) dated 05.07.2018, eFTS 847183/2018.
