Summary of significant developments and major achievements of the Department during the month of June 2024.

1. Vaccination programme- salient achievements

i. FMD Vaccination

Overall, 72.72 Cr. Vaccinations done during the month of June 2024

- a) Round 3 of FMD vaccination has been completed in all States with overall 24.22 crore vaccinations done.
- b) Round 4 FMD vaccination is completed in 11 states and ongoing in 12 states.
- c) Round 5 FMD vaccination has started in Karnataka and Tamil Nadu.

ii. Brucellosis Vaccination

During the month, total of 12 lakh Brucellosis vaccinations have been done (Cumulative 3.61 crore)

iii. Peste des Petits Ruminants (PPR) Vaccination

During the month, 4.4 Crore PPR vaccinations have been done. (Cumulative 14.59 crore)

iv. CSF (Classical Swine Fever) Vaccination

During the month, total 0.24 lakh CSF vaccinations have been done. (Cumulative 51.38 lakh)

v. Vaccination against Lumpy Skin Disease (LSD)

Overall 3.95 crore vaccinations done till June, 2024

2. MOBILE VETERINARY UNIT (MVU)

Overall, 3,182 MVUs are operational in 22 states. During the month, 3,72,916 no. of farmers were benefitted, and 9,04,114 number of animals were treated in 19 states.

3. Activities/Works related to Veterinary Council of India (VCI):

Elections for members of VCI held on 08.06.2024; Lease Agreement for transfer of DMS Land signed.

4. Activities/Works related to Chaudhry Charan Singh National Institute of Animal Health (CSNIAH):

Agreements for “Upgradation of the Biocontainment Facility and associated repair work at CCSNIAH Baghpat” (Service and Confidentiality) between the Department and National Dairy Development Board (NDDB) Signed on 19.06.2024.

5. Dairy Division:

- i. India has hosted the International Dairy Federation’s First Regional Dairy Conference Asia Pacific 2024 from 26 to 28 June 2024 in Kochi, Kerala. The theme of the conference is “*Farmer Centric Innovations in Dairying*”.
- ii. In the conference with the theme Farmer-Centric Innovations in Dairying, the leaders and experts from across the globe collectively addressed key issues affecting the dairy sector, particularly in the Asia-Pacific region and globally. Along with 22 exhibition pavilions that showcased dairy processing and testing equipment and related technologies, 17 distinct startups also displayed their innovations around dairy and allied industries at the event.

6. International Cooperation (IC):

Foreign Visit undertaken by the officials during the month of June, 2024:-

- i. Dr. Abhijit Mitra, Animal Husbandry Commissioner participated in the 7th PPR Advisory Committee Meeting organized by the Food and Agriculture Organization of the United Nations (FAO) and the World Organization for Animal Health (WOAH) held in Rome, Italy during 25-28 June, 2024.
- ii. Dr. Aruna Sharma, Deputy Commissioner (LH) participated in the 1st Regional Workshop on the Global Information and Alert System for Substandard and Falsified Veterinary Products (WOAH-SFVP) for WOAHO focal points for veterinary products and Regulators of Veterinary Medicinal Products in Asia and Pacific held in Bangkok, Thailand during 12-14 June, 2024.
- iii. An Indian Delegation led by Dr. Sandeep Sharma, Director (LH) comprising Dr. Gagan Garg, D.C (Trade) and Sh. Ajith Kumar K., Assistant Commissioner (Dairy) visited Thailand during 17-21 June, 2024 to undertake study of audit system along with market access negotiations for trade of livestock products as well as deepening of cooperation in livestock sector.

Meeting(s) of Hon'ble FAH&D Minister and senior officers with foreign delegations during the month of June, 2024, on issues of livestock trade.

- i. A meeting between Secretary, DAHD and H.E. Mrs. Ana Taban, Ambassador of Moldova to India was held on 18.06.2024 to discuss the recognition of the Veterinary Medicine Faculty, Technical University of Moldova.
- ii. A meeting between Joint Secretary (Trade) and Ms. Anna Shotbolt, Deputy Trade Commissioner, U.K High Commission was held on 03.06.2024 to discuss sanitary issues and to exchange the mutually agreed Veterinary Health Certificate for export of gelatin from UK to India.
- iii. A meeting between Joint Secretary (Trade) and H. E. Mr. Freddy Svane, Ambassador of Denmark was held on 04.06.2024 to exchange the

mutually agreed Veterinary Health Certificate for export of milk and milk product from Denmark to India.

- iv.** A meeting between Joint Secretary (Trade) and Dr. Konstantin A. Malashenkov, Agriculture Counsellor, Embassy of the Russian Federation was held on 12.06.2024 to discuss market access issues between the two countries and to exchange mutually agreed Veterinary Health Certificate for export of pet food (dog and cat food) from Russia to India.
- v.** A meeting between Joint Secretary (Trade) and Ms. Melanie Phillips Regional Agriculture Counsellor, New Zealand High Commission, New Delhi was held on 20.06.2024 to exchange mutually agreed Veterinary Health Certificate for export of milk and milk product from New Zealand to India.
- vi.** A meeting between Joint Secretary (Trade) and Ms. Anna Shotbolt, Deputy Trade Commissioner, U.K High Commission was held on 20.06.2024 to exchange the mutually agreed Veterinary Health Certificate for export of milk and milk product from U.K to India.
- vii.** A meeting between Joint Secretary (Trade) and Mr. Angelo de Queiroz Mauricio, Agricultural Attaché, Embassy of Brazil, New Delhi was held on 27.06.2024 to discuss bilateral cooperation between the two countries including export of genetic material, horns & hooves, pet food and compound feed from Brazil to India. Similarly, Indian side also flagged the market access of Indian dairy products (Camel milk) and buffalo meat to Brazil.

7. National Livestock Mission (NLM):

Animal Welfare Board of India (AWBI) observed Animal Rights Week from 17-23 June 2024. A one-day virtual seminar was conducted on 20.06.2024 which was attended by 450 people across the country.

An MoU was signed with Transforming Rural India Foundation (TRIF) on 25.06.2024 for intensification uptake of schemes by women & other underprivileged sections, skill development & capacity building.

8. 10th International Yoga Day - 21.06.2024

A grand event in view of 10th International Yoga Day was organized on 21.06.2024 at Krishi Bhawan. Shri Rajiv Ranjan Singh, Union Minister FAHD participated with all Government officials.

9. World Camel Day 2024 - 22.06.2024

To mark the International Year of Camelids 2024, declared by the United Nations, ICAR-National Research Centre on Camel Bikaner celebrated 'World Camel Day on 22.06.2024. More than 500 camel breeders from Mount Abu, Sirohi, women farmers and entrepreneurs participated in the programme.

10. Expenditure

Overall Rs 313.99 Cr was incurred in the month of June 2024 as compared to the expenditure incurred Rs 50.47 Cr in the month of May 2024.

11. Grievance disposal:

207 grievances were brought forward, 237 received during the month and 228 disposed off in respect of Department of Animal Husbandry and Dairying under CPGRAM portal.
