- 3) The date to determine the eligibility of all candidates in every respect shall be the last date prescribed for submission of applications in the advertisement in the employment news.
- 4) The date of birth filled by the candidates in the application form and the same recorded in the Matriculation/Secondary Examination Certificate will be accepted for age determination and no subsequent request for change will be considered or permitted.
