2. It is observed that the above mentioned RTI applications seeking inputs from this Department (Dairy Division).

3. I have examined the records in the matter. By way of appeal, the applicant highlighted that the RTI subsequently transferred under section (6(3) of RTI Act to CPIO DMS and Dr Saurabh Prakash, CPIO. No response from Dr Saurabh Prakash, CPIO. The applicant in his appeal requested that Dr Saurabh Prakash, CPIO may be directed to provide point-wise response with sought and related documents may be provided now free-of -cost under Section 7(6) of RTI Act.

4. Dr Saurabh Prakash, CPIO is hereby directed to furnish the information as is available in records and permissible under RTI Act 2005, as sought by the applicant vide applications dated 20.06.2024, within 3 days from the date of issue of this order.

5. The appeal is stands disposed of with the direction as above.

6. In case the applicant is not satisfy with the given direction or the information provided by the CPIO on the above, directions, the applicant prefer 2<sup>nd</sup> Appeal under Section 19(3) of RTI Act, before the Central Information Commission (CIC), CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi 110067 within 90 days of receipt of this communication.
