Office Memorandum

Subject: - Filling up the post of Deputy Manager (Stores & Purchase) in Delhi Milk Scheme by Promotion/Transfer on deputation (including Short term contract).

The undersigned is directed to say that one post of Deputy Manager (Stores and Purchase) belonging to the General Central Service Group 'A' Gazetted, Non-Ministerial is proposed to be filled up in Delhi Milk Scheme, a subordinate office of this Department. The post carries the pay scale of PB-3 - Rs.15600-39100+Grade Pay Rs.6600/-(pre revised) (corresponding revised pay scale of Level - 11, Rs.67700 - 208700/- Total emoluments in the minimum of the scale excluding HRA and Transport Allowance would be Rs.101550/-).

2. As per recruitment rules this post is to be filled by promotion/transfer on deputation (including short term contract) from amongst the officers under the Central/ State Government/Autonomous or Statutory Organisations:

- (a) (i) holding analogous post on regular basis; or
(ii) with 5 years regular service in posts in the scale of Level - 10, Rs.56100-177500/- or equivalent;
or
(iii) with 8 years regular service in posts in the scale of Level - 6, Rs.35400-112400/- or equivalent;
and

(b) possessing the following qualifications and experience;

A. Bachelor's degree of a recognized University or Diploma in Mechanical/ Electrical/ Automobile Engineering of a recognized Institution or equivalent, with five years experience in handling dairy stores in a large dairy plant.

OR

B. Degree in Mechanical or Electrical/ Automobile Engineering of a recognized University or equivalent with three years' experience in handling dairy stores in a large dairy plant.

OR

C. Degree in Master of Business Administration from a recognized University/Institute or equivalent with two years specialised experience in materials management.

3. The Departmental Stores Officers with 5 years regular service in the grade will also be considered and in case one of them is selected for appointment to the posts, the same will be treated as having been filled by promotion.
4. The Departmental Stores Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
5. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed 3 years.
6. The particulars of the eligible officers, who could be spared in the event of their selection, may kindly be sent their application to this Department in the enclosed proforma together with their up to date CR dossier, vigilance clearance, integrity certificate and statement of major/minor penalties imposed during the last eight years within 60 days from the date of issues of this Memorandum. The particulars of the officers received without their CR dossiers or after the due date, may not be considered. It may also be made clear that the officers, who volunteer for this post, will not be allowed to withdraw their name later on.
