- (d) whether the Government proposes to provide more facilities in Bhind and Datia districts as the said districts are dependent on animal husbandry since independence?

(a) to (d) The Department of Animal Husbandry and Dairying, Government of India is implementing various schemes to supplement the efforts of States/UTs for promotion and development of animal husbandry and dairying sector across the country including the State of Madhya Pradesh (including Bhind and Datia districts) such as:

- i. Rashtriya Gokul Mission (RGM),
- ii. National Programme for Dairy Development (NPDD),
- iii. Dairy Processing and Infrastructure Development Fund (DIDF),
- iv. Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDCFPO)
- v. National Livestock Mission (NLM),
- vi. Animal Husbandry Infrastructure Development Fund (AHIDF)

- vii. Livestock Health and Disease Control Programme (LH&DCP) (wherein erstwhile Livestock Health and Disease Control Scheme and National Animal Disease Control Programme were merged with effect from 2021-22)
- viii. Livestock Census and Integrated Sample Survey (LC & ISS)
