1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to

avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

For Supply of Chemicals/Gases etc. in Cylinders, Bidders have to provide free rental period of 30 days for supplied cylinders.

3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

4. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. Description of material : Supply of Ammonia Gas cylinders for a total quantity of 2,000 Kgs. of 50Kgs. each cylinder (total 40 cylinders) for Refrigeration Plants required for refrigeration with Guaranteed Purity of 99.5%.

2. EMD: The participating bidder have to submit a Bid Securing Declaration (BSD) placed at Annexure I duly signed by them and required to upload the same at appropriate place on GeM Portal. Micro, Small and Medium Enterprises (MSMEs) registered under Department of Micro, Small and Medium Enterprises (MSME) and startups as recognised by Department for Promotion of Industry and Internal Trade (DPIIT) are exempted from EMD. Copy of registration as MSEs or Startups is required to be uploaded for exemption from EMD.

3. Delivery Period is the essence of the purchase order. Therefore, delivery may be provided within 30 days of the award of contract. Acceptance of material after delivery period will be at the sole discretion of Competent Authority with or without liquidated damages which may be maximum @ 2% of the total value of the contract for each month or part thereof of delay. Acceptance of material with or without LD charges after expiry of Delivery Period depends upon sole discretion of GM/ authorized officer of DMS.

4. **Offer Validity** your offer should be valid for a period of 60 days.
5. **Payment Terms:** Payment shall be made through RTGS/PFMS within 15 days after receipt, inspection and acceptance of material. The supplier is required to send Bank Detail alongwith Bill for making payment.
6. Full specification along with the literature, if any, of Ammonia Gas of the required purity offered should accompany the offer. The firm should attach a certificate from the manufacturer that their product will conform to IS-662, 1955 Grade I, as required in this enquiry.
7. Rates offer must be firm and final. Rates offered of the goods for delivering the same in DMS premises inclusive of GST, Packing Forwarding, Transportation and Octroi etc.
8. Ammonia Gas is to be supplied in suppliers returnable cylinders preferably having a capacity of 5 Kgs. filled with protective cylinder cap to avoid any damage to the control valve and accidents. The supplier shall be responsible to deliver the cylinders filled with Ammonia Gas to Delhi Milk Scheme for collection of empty cylinders from DMS for which no extra payment shall be made. In case any Gas remained in the cylinders supplied after charging the same may be deducted from suppliers account.
9. Minimum free period for which cylinders may be kept by General Manager, Delhi Milk Scheme will be 30 days. However, supplier may clearly give the free retention period of the cylinders in their offer. Rental charges payable after the free delivery period may be mentioned.
10. It will be specific condition of this enquiry that General Manager, Delhi Milk Scheme at his sole discretion may extend the order for a period of 90 days from the date of its expiry by issue of a letter in writing on any date in the currency of the order.
11. Inspection shall be carried out by the authorized representative of General Manager, Delhi Milk Scheme in DMS premises. In case of rejection, you shall be required to take back the rejected stores & replace the same on free of cost basis within the overall stipulated delivery period.
12. General Manager, Delhi Milk Scheme reserves the right to cancel / short close the order without assigning any reason thereof.
13. All disputes arising out of or raised on this contract, shall be subject to the jurisdiction of Court in Delhi on Territory of Delhi.

7. **Certificates**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
