## **MINUTES OF THE 17<sup>th</sup> NATIONAL STEERING COMMITTEE (NSC) MEETING HELD ON 20<sup>th</sup> February 2024**

The 17<sup>th</sup> NSC meeting of RGM was held under the Chairmanship of Secretary (AHD) on 20.02.2024 at 10.30 A.M. in Krishi Bhawan. The list of participants is at **Annexure-I**.

At the outset, the Chairperson welcomed participants, and it was followed by agenda wise presentation by the Cattle Division to deliberate on the various project proposals for consideration by the National Steering Committee.

### **Agenda 1: Review of previously of approved Breed Multiplication Farms (BMF)**

- 1.1. A detailed status of the BMF projects was presented during the meeting by the Division. It was noted that that total 109 projects have been approved and 55 applicants have received subsidy.
- 1.2. There are 34 approved applicants to whom the subsidy has not been disbursed as they have not yet received bank loan which is mandatory for disbursement of subsidy.
- 1.3. It was decided that applicants who have been sanctioned BMF proposal and are more than 12 months old need may be reviewed by the division in case of no further progress in loan sanction by the bank project sanction letter may be withdrawn.
- 1.4. Further, it was also noted that maximum applications approved under BMF are from Maharashtra, followed by Andhra Pradesh and Gujarat, efforts to be made in other states as well.
- 1.5. It was decided that the division may devise procedures/ norms for cancellation of defunct projects/ projects or project with no substantial progress even after release of 1<sup>st</sup> instalment of subsidy.

### **Agenda 2: Establishment of Centre of excellence for Advance technologies in Bovine production and Research Centre (CoE-ATBPRC) by KLDB**

2.1. Kerala Livestock Development Board has submitted the proposal to establish Centre of excellence for Advance Technologies in Bovine production and research with total cost of Rs 7997 lakhs. The proposal was appraised as per the guidelines of the scheme.

2.2. After a detailed discussion, the proposal was approved with an allocation of Rs 1519.70 lakhs as per the details at **Annexure II**.

### **Agenda 3: Additional funds for procurement of miscellaneous agricultural equipment for cow sanctuary Muzaffarnagar**

3.1. Proposal was submitted for requirement of additional fund for procurement of agricultural equipment for cow sanctuary Muzaffarnagar with total cost of Rs 120 lakhs.

3.2. After a detailed discussion the project was approved with an allocation of Rs. 80.50 lakh as per the details at **Annexure III**

**Agenda 4: Establishment of cattle breeding farm and heifer rearing farm at Sakud, Beed**

4.1. The proposed project for Establishment of cattle Breeding farm and heifer rearing at Sakud, Beed was submitted by the Maharashtra Livestock Development Board with total cost of Rs 6676.42 Lakh. The proposal was appraised as per the guidelines of RGM.

4.2. After a detailed discussion the project was approved with an allocation of Rs. 2319.84 lakh as per the details at **Annexure IV**.

**Agenda 5: Establishment of Breed Multiplication Farm**

5.1 NDDDB has forwarded 34 projects for the establishment of a Breed Multiplication Farms along with net worth and loan sanctioning letters issued by banks/financial institutions.

5.2 Out of 34 proposals, 01 proposal namely Sri Kocherla Jyothiraju from Guntur, A.P. have been deferred as his net worth was less than the required net-worth as mentioned in guidelines.

5.3 After a detailed discussion, it was decided to approve 33 projects received under the component for the establishment of BMF as per the details at **Annexure-V**.

The Meeting ended with a vote of thanks to the Chair.
